 NPPN Reception at the <u>Wonder Bread Factory</u> 641 S Street NW, Washington, DC 20001 Join colleagues and friends on the rooftop of the former Wonder Bread Factory for drinks and light food. Located in the <u>Shaw neighborhood</u>, the 1913 factory baked up bread and Hostess cakes for nearly 80 years. Converted for office use in 2012, it now is home to loft-style offices, including the headquarters of the DC Preservation League. Take a tour of the building and learn how the project worked. Arrive early or stay late and explore the neighborhood--Shaw is home to African American history, restaurants, theaters (U Street was known as "Black Broadway"), and independent shops.
